

Tamakoshi V Hydroelectric Project

Invitation for Bids for the "Contract 1: Civil Works and Hydro-Mechanical Equipment" of Tamakoshi V Hydroelectric Project (99.8 MW)

- 1. Tamakoshi Jalvidhyut Company Limited (TKJVC) "The Employer" has completed the financial closure including the debt portion required for the Project with Employees Provident Fund (EPF) and equity investment will be made from Nepal Electricity Authority (NEA), Local Promoters and General Public and intends to apply a portion of this loan to to cover eligible payments under the Contract for "Contract 1: Civil Works and Hydro-Mechanical Equipment" of Tamakoshi V Hydroelectric Project; Contract Identification No: TKJVC/TKV/079-80/ICB/EPC-01. Bidding is open to all eligible as per Section V of bidding document.
- 2. Tamakoshi Jalvidhyut Company Limited invites electronic bids from eligible bidders for the construction of "Contract 1: Civil Works and Hydro-Mechanical Equipment" of Tamakoshi V Hydroelectric Project through Engineering, Procurement and Construction (EPC) mode under International Competitive Bidding Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Work experience of similar size and nature:

- a. Participation as Prime contractor, management contractor, or subcontractor, in at least one EPC/Turnkey/DB/Item Rate Contract within the last ten (10) years, with a value of at least **equivalent NRs. 4,907 million** that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
- b. Participation as Prime contractor, management contractor, or subcontractor, Contract within the last ten (10) years, with a value of at least **equivalent NRs 3,067 million** that have been successfully or are substantially completed.
- c. For the above or other contracts executed during the period of last ten (10) years, a minimum construction experience in the following key activities:
 - i. At least one contract having headrace tunnel of minimum length 4 kilometer in a single stretch in a single project;
 - ii. At least one pressure shaft (inclined or vertical) of minimum finished dimension of 3.4 meter diameter and 100 meter height for a single project;
 - iii. At least one underground powerhouse or cavern of not less than 12 meter finished width;
- d. Minimum Average Annual Construction Turnover of the best 3 years within the last 10 fiscal years: *NRs.* 4,600 *Million*
- e. Bidding capacity should be equal to or more than NRs. 12,153 Million.
- f. Able to demonstrate adequate Manpower and Equipment to be used for the Project.
- g. Able to produce Concept paper for Understanding of the Broject and Proposed Design

- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit the Technical Bid and the Price Bid, as per the provision of ITB 21 of the Bidding Document.
- 4. - 5. Bidder submitting their bid electronically shall download the bidding documents for esubmission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's account as specified below.

- 6. Pre-bid meeting shall be held at *Tamakoshi Jalvidhyut Company Limited*, *House No. 106*, *Okharbot Marg, Thapagaun*, *Kathmandu*, at 13:00 hours NST on August 10, 2023.
- 7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hours NST on August 27, 2023. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours NST on August 27, 2023 at the office of Tamakoshi Jalvidhyut Company Limited, House No. 106, Okharbot Marg, Thapagaun, Kathmandu. Absence of Bidder's representative shall not affect the bid opening procedure. Bids must be valid for a period of 180 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of NRs. 307 Millions, which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
